Statement of intent

At SS Peter & Paul, we aim to close the progress and attainment gaps between pupil premium and non-pupil premium pupils through:

- High quality first teaching through Universal classroom provision; enabling all children to access all areas of the curriculum.
- Effective differentiation within the classroom to provide additional support for pupils with an attainment gap.
- Targeted support for pupils struggling to access the curriculum offer due to their disadvantaged circumstances.
- Specialist support from outside agencies in order for children and families to effectively access the school curriculum.
- Providing additional resources to assist pupils with closing the attainment gap.

Challenges

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

Looking at our outcomes for Pupil Premium children last year, Summer 2023, our children have achieved well. The picture improves as children move higher up the school.

EYFS GLD – No Pupil Premium children in Reception to assess against GLD.

Y1 PSC – 57% of our Pupil Premium children in Y1 passed Phonics Screening Check. (4 out of 7)

Y2 SAT's – 67% of our Pupil Premium children achieved the expected standard in Reading. (4 out of 6)

- 50% of our Pupil Premium children achieved the expected standard in Writing. (3 out of 6)
- 67% of our Pupil Premium children achieved the expected standard in GPS. (4 out of 6)
- 67% of our Pupil Premium children achieved the expected standard in Maths. (4 out of 6).

Y4 MTC – 71% of our Pupil Premium children scored over 20/25 in the MTC. (5 out of 7).

Y6 SAT's – 80% of our Pupil Premium children achieved the expected standard in Reading. (4 out of 5)

- 80% of our Pupil Premium children achieved the expected standard in Writing. (4 out of 5)
- 60% of our Pupil Premium children achieved the expected standard in GPS. (3 out of 5)
- 80% of our Pupil Premium children achieved the expected standard in Maths. (4 out of 5)

Overall –

75% of Pupil Premium children are working at the expected standard in Reading (27 out of 36)

56% of Pupil Premium children are working at the expected standard in Writing (20 out of 36)

58% of Pupil Premium children are working at the expected standard in GPS (21 out of 36)

58% of Pupil Premium children are working at the expected standard in Maths (21 out of 36)

Attendance –

33% of Pupil Premium children are classed as Persistent Absentees with below 90% (12 out of 36)

Vulnerable –

42% of Pupil Premium children are on 'Vulnerable Pupil' list who may need pastoral support (15 out of 36)
